COVID-19 Procedures

We will be following safety protocols based on state and UKC guidelines and are subject to change.

Hand sanitizer to be used before entering and when leaving building.

Crating will be in your car, no crating in building. (Volunteers please contact Pam)

Break taken between classes to sanitize chairs

Masks are highly recommended and may be required.

Access limited to 6 exhibitors in the building at a time. When one is finished, that exhibitor will leave and the next exhibitor will be allowed into building.

Judging starts at 8:00 on Saturday & Sunday. Any breaks/lunch will be at the judge's discretion.

PLEASE NOTE: The building will be open to exhibitors at 7:00 on Saturday and Sunday. Building is NOT available for set up or training on Friday before the trial.

Ribbons and Prizes: Rosettes will be awarded for 1st, 2nd, 3rd and 4th place in each class. Rosettes will be awarded in each obedience trial for High in Trial, High Combined and High Scoring Junior Handler (please list your junior # on form). All qualifying scores receive qualifying ribbons. Title Rosettes will be given for any new titles achieved at this trial.

Please be sure all information is filled in on your form and correct classes and correct entry fees are included. Your entry cannot be added to the trial if it is missing any and/or incorrect fees are included. There is a limit to the number of entries each day and if your entry cannot be added due to missing info or incorrect fees, the trial may fill before the discrepancy can be fixed!

All Entry Fees

\$27.00 Pre-entry for classes for all exhibitors

\$23.00 2nd entry for classes, SAME dog and SAME trial – PLEASE NOTE, there are TWO separate trials each day. If you have questions regarding your entry fee totals, please contact trial secretary.

The trial secretary will accept class move ups (requested by e-mail) for Friday p.m., no later than Friday, March 5, 2021. Please make any requests for move ups for Saturday and Sunday to the Trial Secretary before you leave the trial each day. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused, or the trial is canceled because of storms, hurricanes or conditions injurious to exhibitors and spectators. In addition, after closing date, there are no refunds for bitches in season. Returned checks will not constitute a valid entry.

The entry form is attached to this Premium. Please use one entry form per dog. IMPORTANT -- All blanks on the entry form must be filled in. All this information is needed in order to process your entry. Choose your classes carefully and please print clearly. Remember to sign the form. Owners are responsible for the accuracy of information in the entry forms. If you have any questions regarding the form, please contact the Trial Secretary.

You must provide either a UKC registration number or temporary number. Otherwise the entry will be rejected. Note: you can obtain a temporary number over the phone (616-343-9020) or on the web at <http://www.ukcdogs.com>. Temporary numbers will NOT be available at the trial.

Which class can you enter?

(please see the rules for more information and specifics regarding each class)

- No dog may be entered in any class for exhibition only.
- No dog may be entered more than once in the same Obedience class.
- No dog may be entered in more than one division of the Novice, Open or Utility class.
- No dog may be entered in the A divisions of the Novice B/C, Open, and Utility class at the same trial.
- No dog may be entered in the A or B divisions of the Novice class and an Open class at the same trial.
- No dog may be entered in the A division of the Open class and a Utility Class at the same trial.
- A dog that has earned a UCD may not compete in Pre-Novice, Novice A, or Novice B, but may compete in Novice C, Open class and any other additional titling classes.
- A dog that has earned a UCDX may not compete in the Pre-Novice or Beginner Novice classes but can continue to compete in the Novice C, Open B, Utility, and any other additional titling classes.
- A dog that has earned a UUD may not compete in the Pre-Novice, Beginner Novice, Novice A, or Novice B classes but can continue to compete in the Novice C, Open B, Utility B, and an other additional titling classes.
- A dog that has earned the UOCH may no longer complete in the Novice C or Advanced Novice classes but may continue to compete in the Open B, Advanced Open, Utility B, Master, and Elite classes.

PSOAC, Ironclad K9 and the UKC are not responsible for loss, accident, injury or theft with regard to exhibitors, animals, property or vehicles.

The exhibitor shall hold the show committee, PSOAC, Ironclad K9 and UKC harmless against any legal proceeding arising from any accident.

All dogs must be on leash or crated while not being shown. Exhibitors are asked to please pick up after their dogs.

Judges decisions are final.

Notice to Exhibitors

Due to space limitations: ONLY dogs ENTERED will be permitted in the building during the trials.

Dogs must be crated unless they are getting ready to go in the ring. We appreciate your co-operation!

Please be considerate of others and clean up after your dog at the trial site and motel facilities. Owners/handlers not cleaning up after their dogs are subject to dismissal from the trial without refund.

The safety of the dogs is of primary importance. By entering this trial exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all of the obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial judge and/or trial committee, be asked to leave the show site. In such case, no refund of any fees will be made.

The Judge is not required to wait for any dog holding up the judging of a class.

After the trial closes on March 5, 2021, no refunds will be given or entries accepted after that date.

Bitches in season will not be allowed anywhere on the show grounds during the trial weekend, Saturday and Sunday, March 20 & 21, 2021.

NO alcohol, illegal drugs, or SMOKING permitted on these grounds.

Food available at nearby fast food restaurants.

There is overnight RV parking available at the site, but NO overnight parking on the grass directly across from the building. No hook ups are available.
